The time being 7:45 PM the following motion was made:

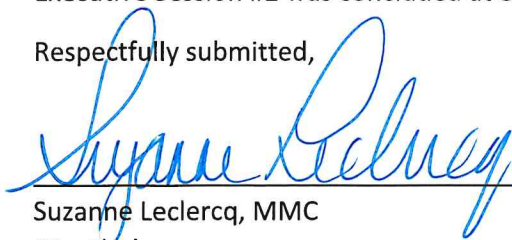

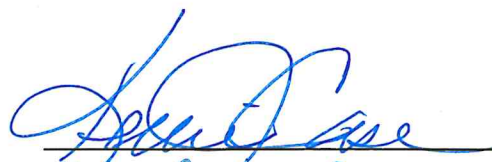
